membership terms and conditions -

as prescribed by Turtle Creek Golf Estate (Pty) Ltd, the management company which controls the golf club

- 1. On joining the Goose Valley Golf Club the member accepts and agrees to be bound by these conditions of membership. Members and Guests must also adhere to the rules within the club.
- 2. Use of the facilities of the club and use of the club premises is strictly subject to the rules and regulations of the club in effect at any time.
- 3. Payment of the annual membership subscriptions will entitle the member to membership of the club for a twelve-month period, or the balance thereof.
- 4. Membership is automatically renewed at the beginning of each financial year from 1 October each year.
- 5. Resignations must be in writing and received by the club by not later than 31 August, at least 30 (thirty) days prior to the new financial year.
- 6. In the event of the annual membership fee not being paid within the date of its expiry, it is deemed to have expired and it will be necessary for the member to re-apply for membership. The joining fee will be waived if renewal occurs within a fortnight of membership expiring. The subscriptions are still due and interest may be charged on all overdue subscriptions.
- 7. Membership does not include maintenance of a handicap. Handicaps are not required as part of membership, however, all competitions require a valid handicap. If a member requires a handicap, an additional fee in accordance with the SCGU is charged for this affiliation as well as for the handicap maintenance which is carried out in terms of the SAGA requirements.
- 8. In the event of losing a membership card a fee will be payable for the replacement.
- Membership may be terminated by the management for violation of any rules or regulations of the club or for conduct deemed by the management to be detrimental to the welfare, good order, safety or character of the club or its members.
- 10. Membership is not transferable and membership fees are not refundable under any circumstance.
- 11. Children under 12yrs must be accompanied by an adult or guardian aged 18 years or over when entering the club and using the facility.
- 12. Goose Valley Golf Club is not responsible for the loss of personal items or damage to persons or property either on the premises or in the car park.
- 13. Goose Valley Golf Club will endeavour to ensure that all facilities and equipment are maintained in working order but the club accepts no responsibility to the member for the failure or breakdown of any equipment or facility however caused.
- 14. Goose Valley Golf Club reserves the right to schedule tournaments, competitions or events at various times throughout the year during which the use of the course may be limited to participants or otherwise restricted.
- 15. No driving of golf carts anywhere on the estate by persons not in possession of a valid driving licence. Criminal and/or civil action may be instituted against any transgressors of this rule.
- 16. No one is permitted on the course after hours
- 17. No collecting of golf balls on the course is permitted
- 18. No casual, informal playing is permitted on the course **ALL** golf games to be booked and prepaid at the Proshop. Absolutely no starting in the middle of the course.
- 19. In the event of any dispute arising between a member and Goose Valley Golf Club the decision of Turtle Creek Golf Estate (Pty) Ltd will be final.
- 20. The management of Goose Valley Golf Club reserves the right to amend and add to these conditions of membership and rules as it sees fit and the member shall observe any amended or additional conditions or rules so made.
- 21. Membership fees and admissions will be reviewed annually. Goose Valley Golf Club reserves the right to increase membership or admissions as required within reason.
- 22. All correspondence from the club and management will be via email and displayed on both the clubhouse notice boards and on the course website (www.goosevalleygolfclub.com). All members are to ensure that the Club is always in possession of correct contact details in order to be kept abreast of all changes, developments and upcoming events.
